SUBJECT: Adult Dependent Child Eligibility up to Age 26 – Expanded Eligibility
For Active Employee Medical & Prescription Drug Plans

On April 1, 2011 all State and County employees were informed that their adult dependent child up to age 26 could be added to their medical and prescription drug plans effective July 1, 2011 EXCEPT if your adult dependent child was employed and eligible for medical and/or a prescription drug plan through his/her employment. Effective July 1, 2011 this exception will be removed. Your adult dependent child up to age 26 who is employed and eligible for medical and/or a prescription drug plan through his/her employment **MAY NOW BE COVERED UNDER YOUR PLAN FOR MEDICAL AND/OR PRESCRIPTION DRUG.**

Q1. Why is this change being made?

A1. The HGEA (with the exception of Bargaining Unit 09), recently settled its contract that changed the employer contribution from 60% to 50%. This change resulted in the EUTF plans losing their “grandfather” status effective July 1, 2011 under the Affordable Care Act, passed by Congress in 2010. As such, EUTF is now required to expand dependent eligibility to include adult dependent children up to age 26 who are employed and eligible for coverage under their employer. This change will apply to all EUTF medical and prescription drug plans for active employees and all Bargaining Units.

Q2. What do I need to do?

A2. If your wish is to cover your adult dependent child up to age 26 (who is employed and eligible for coverage under his/her employment) under your plan:

- On the EC-1 or EC-1H check the box “Open Enrollment” and write below the box “adding adult dependent child”
- Be sure to complete the information on your adult dependent child in Section 4
- Be sure to sign the form in Section 6.

Q3. When must I turn the EC-1 or EC-1H form in?

A3. The EC-1 or EC-1H must be turned in to your personnel office **by July 6, 2011.**

Q4. When will the coverage be effective?

A4. July 1, 2011

Q5. If there is a change in rates due to the addition of my adult dependent child (changing from self to 2-party or 2-party to family), when will the change in rates be reflected on my paycheck?

A6. Since this is a retroactive enrollment to July 1, 2011, the change in premiums will occur on the August 5, 2011 paycheck or the August 20, 2011. There also will be an adjustment in your

deductions to collect the difference in premiums (self to 2-party or 2-party to family) for the July 20, 2011 and the August 5, 2011 pay checks (only if the deduction change is on the August 20, 2011 paycheck).

Q6. Who can I contact if I have questions?
